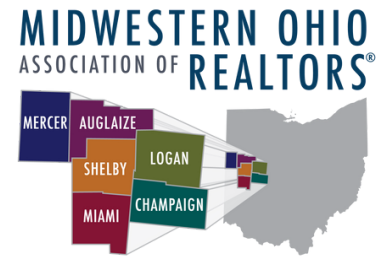


# NAR Settlement Timeline for MOAR Members
